Sunbury Revitalization, Incorporated relies on the work of committees to reach its goals. Three committees are comprised of SRI members who share their talents and ideas to help Sunbury and its businesses prosper.

### ***Business and Economic Development Committee:***

The committee works with existing businesses to solve problems. It also works to bring new businesses to the area by compiling a list of available properties, facilities and services.

This committee is also responsible for the Shining in Sunbury Business Expo that is held in April at the Sunbury Community Center. The purpose of the expo is to bring the businesses of Sunbury together in one place to show the Susquehanna Valley why Sunbury is a great place to do business.

### ***River Festival Committee:***

This group coordinates and plans the annual fall festival, which highlights Sunbury's heritage and history. Held in September, Riverfest grows larger each year. Crafters, demonstrations, entertainment and historic displays are among the attractions that bring thousands to Sunbury's riverfront.

### ***Promotions Committee:***

The committee works with retailers throughout Sunbury on citywide promotions, which feature the advantages of shopping in Sunbury. The group develops a promotional calendar is prepared and followed each year.

### ***Lite Fest***

This committee is responsible for decorating the downtown and river front area for the Christmas season.
